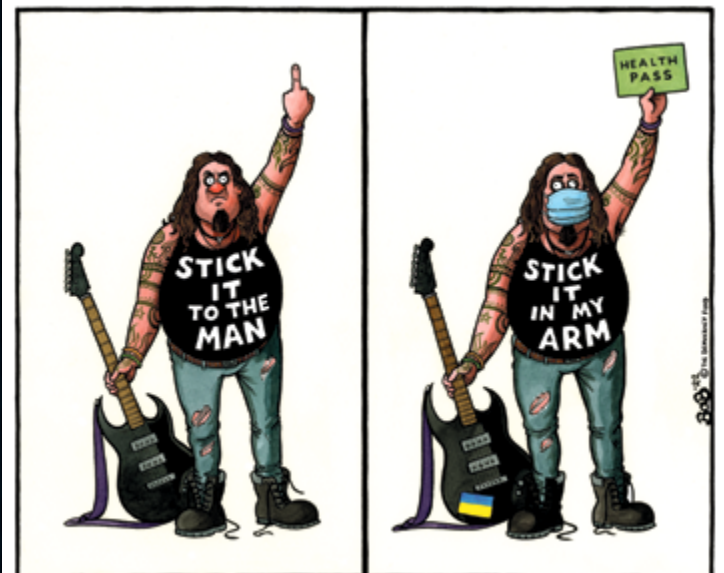
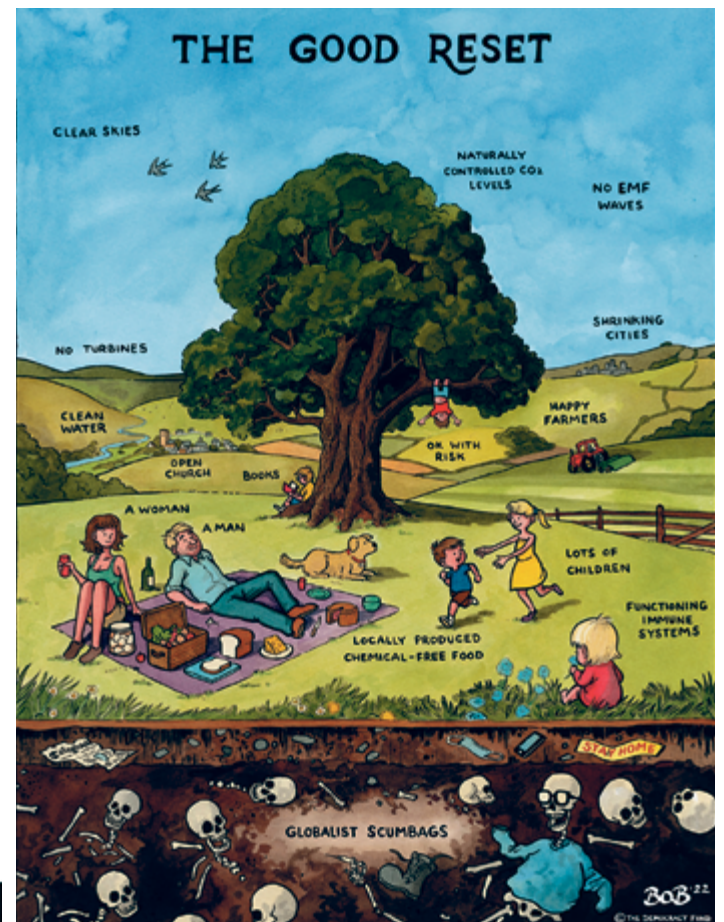

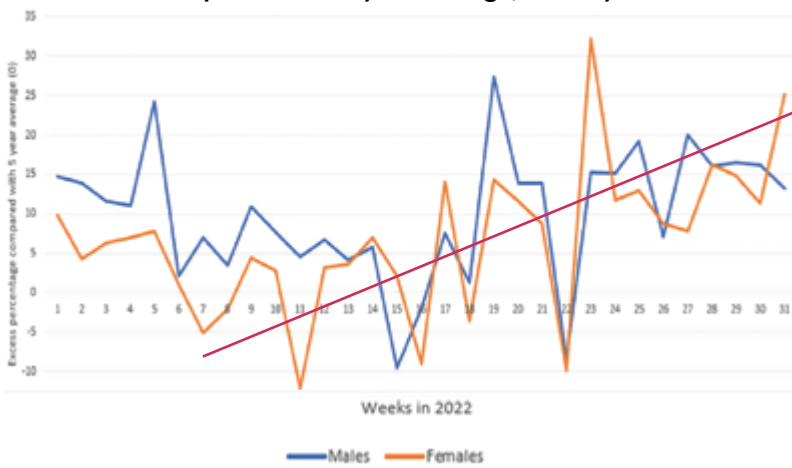

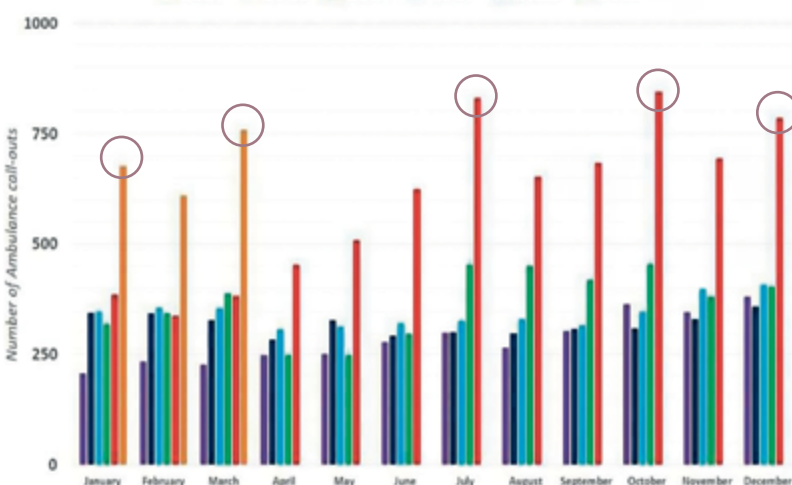
Percentage of excess deaths in Males and Females up to Week 31, 2022 compared with 5-year average, 45-64 year-olds

1,100 eminent Scientists declare: 'There is NO climate emergency'

CLIMATE science should be less political, while climate policies should be more scientific. In particular, scientists should emphasise that their modelling output is not the result of magic: computer models are human-made.

What comes out is fully dependent on what theoreticians and programmers have put in: hypotheses, assumptions, relationships, parameterisations, stability constraints, etc. Unfortunately, in mainstream climate science, most of this input is undeclared.

To believe the outcome of a climate model is to believe what the model makers have put in. This is precisely the problem of today's climate discussion to which climate models are central. Climate science has degenerated into a discussion based on beliefs, not on sound, self-critical science. We should free ourselves from the naïve belief in immature climate models. In future, climate research must give significantly more emphasis to empirical science.

There is no climate emergency

A worldwide network of over 1,100 scientists and professionals has prepared this urgent message. Climate science should be less political, while climate policies should be more scientific. Scientists should openly address uncertainties and exaggerations in their predictions of global warming, while politicians should dispassionately count the real costs as well as the imagined benefits of their policy measures.

Natural as well as anthropogenic factors cause warming

The geological archive reveals that Earth's climate has varied as long as it has existed, with natural cold and warm phases. The Little Ice Age ended as recently as 1850. Therefore, it is no surprise that we now are experiencing a period of warming.

Warming is far slower than predicted

The world has warmed significantly less than predicted by IPCC on the basis of modelled anthropogenic forcing. The gap between the real world and the modelled world tells us that we are far from understanding climate change.

Climate policy relies on inadequate models

Climate models have many shortcomings and are not remotely plausible as useful policy tools. They blow up the effect of greenhouse gases such as CO². In addition, they ignore the fact that enriching the atmosphere with CO² is beneficial.

CO² is plant food, the basis of all life on Earth

CO² is not a pollutant. It is essential to all life on Earth. Photosynthesis is a blessing. More CO² is beneficial for nature, greening the Earth: additional CO² in the

air has promoted growth in Earth's plant biomass. It is also good for agriculture, increasing the yields of crops worldwide.

Global warming has not increased natural disasters

There is no statistical evidence that global warming is intensifying hurricanes, floods, droughts and suchlike natural disasters, or making them more frequent. However, there is ample evidence that CO²-mitigation measures are as damaging as they are costly.

Climate policy must respect scientific and economic realities

There is no climate emergency. Therefore, there is no cause for panic and alarm. We strongly oppose the harmful and unrealistic net-zero CO² policy proposed for 2050. If better approaches emerge, and they certainly will, we have ample time to reflect and re-adapt. The aim of any

policy should be 'prosperity for all', by providing reliable and affordable energy at all times. In a prosperous society, men and women are well educated, birthrates are low and people care about their environment.

The World Climate Declaration (WCD) has brought a large variety of competent scientists together from all over the world*. The considerable knowledge and experience of this group is indispensable in reaching a balanced, dispassionate and competent view of climate change.

How data capitalism makes YOU the product

Big Tech's goal is to automate human beings

Until the late 1970s, computers were large and expensive contraptions and, as such, they were the preserve of governments, universities and corporations.

Computers were often referred to as mainframes, a term derived from the fact that they were housed in large metal cabinets. A single mainframe would typically be used by many people via dumb-terminals from within the same building.

By the 1980s, however, the PC had arrived on the scene. The significance of the word is lost now, but it was revolutionary at the time because "PC" once stood for "personal computer". This meant that it wasn't shared with others, but was yours and yours alone.

Unlike the 80s, the computing devices we use today are not really ours any more - even though we are the ones who pay for them. For example, the continuous software updates common in modern devices facilitate a backdoor allowing any change to be made or restriction imposed, at any time, without our knowledge, consent or control.

In reality, our smartphones and laptops are tools used to monitor what should be our private communications and interactions. Android phones, as a case in point, typically upload between 4.4 and 13.6 MB of tracking data to Google servers every day.

How on earth did things come to this?

If there is one thing that computers do well, it is automation. Although it was once widely held that the internet would engender freedom, with the benefit of hindsight it should be no surprise

that the large-scale automation it actually facilitates lends itself to the economies of vast scale, rather than those of small or medium sized enterprises.

As a result, the traditional model of capitalism, in which companies compete for paying customers in a free market, is breaking down. In its place has arisen surveillance capitalism - a phoney capitalism in which the product may ostensibly be free, but behavioural data is harvested from its users in order to exploit them in other domains.

Such data is not only be used for the targeting of ads, but also in highly manipulative ways through the use of subliminal cues and nudges, and rewards and punishments in order to nudge people into profitable behaviours.

In order to succeed, this must happen below the level of everyday awareness.

Indeed, it has succeeded and beyond the dreams of avarice. We can see now the inspiration behind so called 'Smart Cities' and the UK government's 'Nudge Unit'.

While a cost-benefit analysis may be out of scope here, it is far from clear that the internet has universally improved the quality of human existence. Rather, it now threatens us with a new kind of tyranny - one which aims to subject every aspect of human existence to automated surveillance. We need only look to the Chinese Social

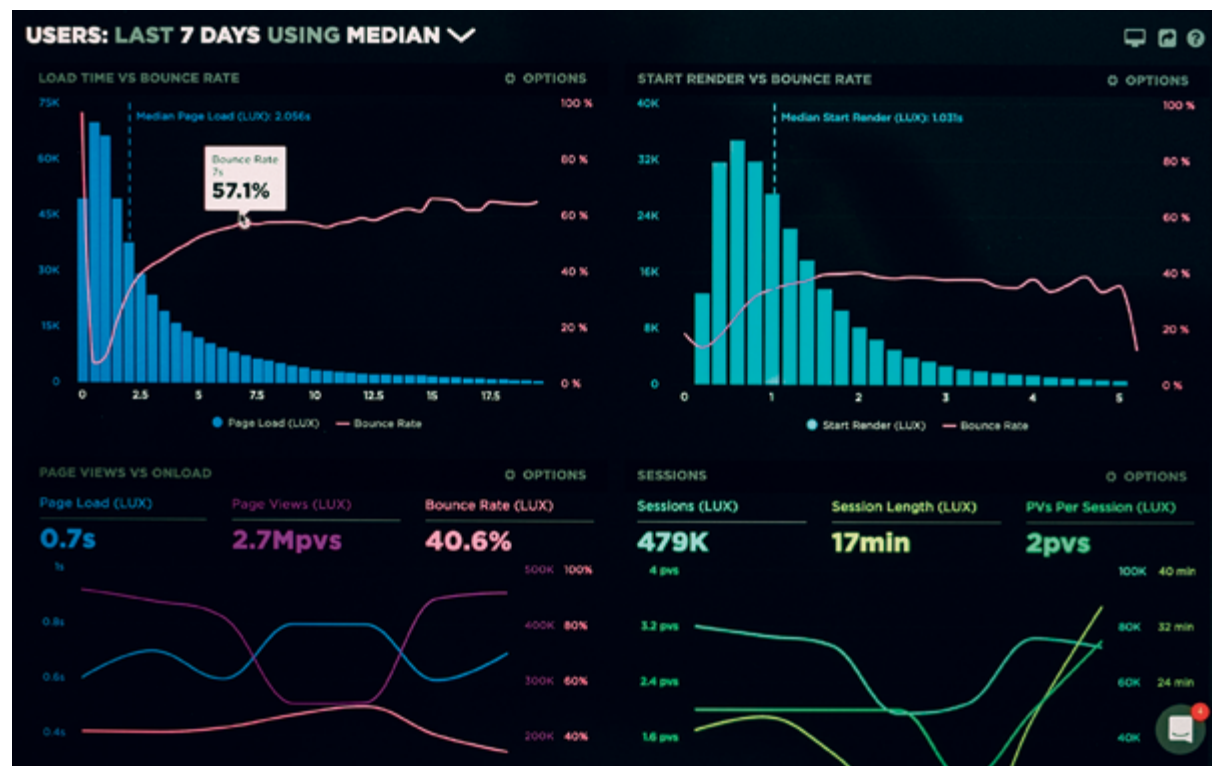

Credit System to see what such a future would look like.

It may be a tad depressing to realise that the primary motivation behind the worldwide rollout of 5G is not to simply provide everyone with fast internet on the go, but to facilitate the so-called 'Internet of Things', in which even the most trivial of devices will be online and under AI control.

History, however, is full of upheavals in which all that once seemed so certain is uprooted in short order. The sudden and very unexpected collapse of the Soviet Union is a case in point.

I'm not about to suggest that the internet will suddenly cease to exist, and that we will somehow be transported back to the 1980s. What I am suggesting is that the business model of surveillance capitalism - which has succeeded thus far by quietly looting everyone - is unsustainable long-term.

In her seminal work, *The Age of Surveillance Capitalism*, Professor Shoshana Zuboff writes that Google - the first company to exploit human behavioural data - understood that users would never accept the unilateral claiming of their raw human experience in exchange for being able to use free online apps.

Therefore, it was necessary for Google's services to act as a one-way mirror in order to keep people from realising the true nature of what was being taken from them.

It is the compulsion of every technology company, however, to automate the very thing at the heart of their value generation activity, and it is this which will ultimately kill the goose which lays their golden egg.

In the end, the people will own nothing and there will be nothing left for surveillance capitalism to plunder.

As we now belatedly wake up to surveillance capitalism, and begin to see it for what it really is, we must reject it and reclaim our sovereignty. Moreover, we must reject the 'everything free' model as being too good to be true, and expect to conduct honest transactions in exchange for things of real value, without surveillance and manipulation.

Computers and smartphones won't be going away, but we can reimagine the personal computer for the 21st century as a privacy-

centric device under the control of individual human beings, rather than a big tech singularity.

De-Google'd phones, for example, running alternatives to Android and iOS are now available and demand for them is starting to grow. For laptops and desktops, Linux represents a perfectly viable operating system for everyone - even for the most non-technical of users.

The real game changer, however, may be the widespread adoption of open source software such as NextCloud and Mastodon. These are 'back-end' applications which allow individuals, groups and small businesses to host their own private clouds and social media networks.

In the future, we shall have no need for surveillance-based services.

Driving a wedge between parents and children

For more than a century, a very reprehensible and sinister practice took place in Welsh schools in the guise of the 'Welsh Not'.

Medical surveillance net is closing around us

Demand answers and create change within the NHS

YOU may remember an article from the *Byline Times* in May 2021 entitled: *The Government wants to sell your GP medical records, here's how to opt-out*, by Phil Booth.

And you may have opted out by signing forms both with the GP and the NHS. The public outcry led to the project being delayed, a move apparently welcomed by the Information Commissioner's Office (ICO).

Close call. But has our data been quietly stolen behind the scenes?

Around the time that covid-19 was no longer deemed to be a High Consequence Infectious Disease (HCID) on 19 March 2020, the Department of Health and Social Care (DHSC) quietly issued a Control of Patient Information (COPI) notice. It read: "This notice is necessary so that NHS Digital can lawfully and efficiently disseminate confidential patient information... for the purposes of the health service or other persons employed or engaged by a government department or other public authority in communicable disease surveillance in connection with the health and social care system's management of the response to covid-19."

These notices remain in effect to this day. A Notice issued under a Regulation cannot legally remove our rights under the Data Protection Act 2018, or remove our lawful right to confidentiality. They used covid-19 to justify it, but, according to the public record, that pretext did not exist.

The British Medical Association (BMA) confirms that "GP practices are data controllers for the data they hold about their patients". I asked two practices if any of my data had been shared with NHS Digital or other third party. I received assurances that it had not. I asked for assurance that my opt-out form had been received, and that they needed nothing else

from me to ensure no data left the practice or could be accessed by NHS Digital or other third party. I received such assurance. I requested my full medical record. Imagine my surprise when the following note appeared every month or so over the past two years: "Additional SCR dataset uploaded under COPI regulations. Summary Care Record [SCR] Update sent as part of a Central Bulk Upload. The patient's preference is for only core items to be included in their Summary Care Record. This has been overridden so that additional items will be included in this patient's Summary Care Report."

I asked for an explanation of what this included and what the legal justification was. The answers varied from its being about sharing prescriptions with the pharmacist (my prescriptions have been electronic for many years), to routine blood tests, to a statement that my SCR had been automatically shared as they had no record of an SCR opt-out form, to no explanation is available as they referred it to the Medical Protection Society. I also received an assertion that covid-19 has been considered an HCID from March 2020 to 2022 and therefore they did what the COPI Notice instructed.

The SCR you see online has a note stating: "This view of your record is not your actual Summary Care Record". How can it be right that we are the ones unable to access our own medical data? The real SCR dataset is comprehensive, including potentially 3,000+ data items describing our full medical history.

Additional Information includes:

- significant medical history
- reason for medication
- anticipatory care information (such as information about the management of long-term conditions)
- end-of-life care information
- immunisations

Just the data you would need for a covid passport, perhaps?

My record also shows "Covid Patient Screening". I have not seen a GP during this time, so I asked what this entailed and how it was done. They were unable to answer.

I asked about several entries saying: "SystemOne Outgoing Record Sharing consent changed to Not Asked – Record Shared". The response was, "Record Shared" means the record was not shared.

It would seem opt-outs and patient preferences count for nothing, despite public assurances to the contrary.

How can NHS Digital have all adult data if GPs told me they haven't shared any?

Where might they have got this information? Helpfully the NHS tells us that the General Practice Extraction Service (GPES) provides two of the seven sources for Databricks.

Is this where our SCR data has gone? This data is enabling AI to make judgements about who should be jabbed.

On July 1, 2022, the COPI Notices were again extended. They are seeking an "alternative, sustainable legal basis" on which to permanently destroy our fundamental right to medical privacy. The Information Commissioner's Office, it appears, is helping NHS Digital by recommending that it agrees a National Data Sharing Agreement for GP Connect, so that they can continue to benefit from this

sharing of our most precious data once the COPI Notice expires.

It will then no longer need to be referred to in the GPs' or NHS Privacy Notices, and patients will be none the wiser. Doesn't this give the ICO a potential conflict of interest when investigating data complaints about GPs, NHS Digital, GP Connect and COPI Notices?

I find it unforgivable that GPs and their Data Protection Officers are unaware of the status of covid-19, given many of us mere members of the public have known this since March 2020. They appear to have taken no legal advice and simply followed orders, despite being legally accountable for protecting our data. The covid-19 status surely also begs the question as to whether any of the other covid measures were lawful or legal.

I find the NHS long-term plan terrifying, and so I hope I have inspired you to ask your own questions. Perhaps lawyers and journalists will also investigate?

The more of us who demand answers, the more unlikely it is that they will succeed. We have more power than we know, when we act together.

Ultimately, we need a system which respects the fact that this is OUR data, and we should be the ones who decide who we can trust with it.

An unhealthy obsession with safety

Keeping us safe is our job, not that of the state

I HAVE a bit of a reputation in my local railway station. Step onto the stairs there, and a canned electronic voice implores you to ‘please hold the handrail, and take care’ – at which point, in the absence of a sick-bag easily to hand, I volubly tell this robot to shut up.

In 2019, Greg Lukianoff and Jonathan Haidt wrote at length about censorial ‘safety-ism’ in their book, *The Coddling of the American Mind: How Good Intentions and Bad Ideas Are Setting up a Generation for Failure* (Penguin). The ‘safety-ism’ term has also been aptly applied to the extreme social distancing measures imposed during the so-called covid ‘pandemic’.

In their deployment of the term, Lukianoff and Haidt show how a culture of ‘campus safety’ has engulfed universities, with an ever-growing army of administrators aiming to ensure students are ‘comfortable consumers’, even if this means severely restricting their exposure to new or controversial ideas.

For these writers, then, the rise of safety-ism in American society has generated beliefs and practices that hinder students’ healthy socio-emotional development. And it’s easy to see how these insights can apply more generally right across a society unhealthily obsessed with safety.

The insufferable safety-ists who are imposing this infantilising ideology seem to have forgotten (or are incapable of understanding) the great William Blake’s urgent injunction from 1793: “Without contraries is no progression. Attraction and repulsion, reason and energy, love and hate, are necessary to human existence.”

Blake could easily have added ‘danger and safety’ to his list. The key point is that in a world where all is ‘safe’, what happens to our development and learning?

And rather than seeing safety as just one concern amongst many that need careful balancing in living a responsible life, safety-mindedness becomes a self-fulfilling, quasi-sacred value, insinuating itself into modern culture, and colonising the very way people think about themselves in relation to the world. Positioning, and even defining, us through its fear-driven language. You know what happens when a politician tells you that they are ‘keeping you safe’.

Humanistic Psychology’s Karpman ‘Drama Triangle’ is also relevant here. Start out from the fallacious assumption that the world is inherently unsafe, and it (consciously and unconsciously) becomes a dangerous persecutor from which a rescuer needs to protect us – in this case, the nanny technocratic state – lest we become hapless victims of it. A culture of ‘victimhood’ is thus surreptitiously created, whereby the very ways we think about ourselves and our relation to the world are contaminated by this ideology.

Before critics robotically deploy their ‘far right’ trope, it’s clear that indiscriminate, industrial-scale mass infantilisation is an issue relevant to everyone, irrespective of conventional politics. Those on the political left sometimes refer to ‘anti-safetyism’ as reactionary – a preoccupation with freedom at all costs, even if (as they disgracefully claimed during covid) it means sacrificing granny.

Such woke criticism abjectly fails to comprehend just what is at stake here. Safety-first obsessions have all manner of toxic unintended consequences – one being to render us far more susceptible to control, manipulation and the colonisation of our psyches, by those happy

to ride rough-shod over our best interests.

The parallels with industrial-scale mass vaccination, where everyone is fallaciously assumed to require ‘the jab’ irrespective of individual needs and differences, will be obvious.

What is at stake here is personal responsibility. Malign forces are at work across modern culture, actively wishing to infantilise us – keeping us in a ‘victim’ level of consciousness, promoting fear-driven dependence, determined to convince us that we are incapable of looking after ourselves. This renders us far more malleable and amenable to the ‘Agenda 2030’ technocratic control systems they are building right now.

Technocrats want us to meekly collude with our positioning as hapless and helpless victims who need others (i.e. the state) to Keep Us Safe™. But we emphatically do not need to succumb to this poisonous ideology.

We urgently need a concerted push-back against infantilising safety-ism, wherever and however it manifests. Every piece of resistance matters, however small. If we can all start embracing mass, principled non-compliance with this toxic zeitgeist, then the safety-ist ideology will soon begin to disintegrate.

Our derision and contempt are things we need to start proclaiming, rather than meekly colluding with or accepting this infantilising madness.

I cannot wait for the day when I hear another fellow traveller swearing at the nanny state robots at Swindon railway station. For the sake of our healthy evolution, please join the pushback against robotic, intelligence-insulting safety-ism.

The individual doesn’t count

Totalitarianism has sneaked in disguised as benevolence

INDIVIDUAL rights, as seen in the reaction to the overturning of the Roe versus Wade judgement by the U.S. Supreme Court, are subject to double standards.

Justin Trudeau promised American women an abortion in Canada, but they cannot cross the border unless they have had the covid shots. To pro-choice activists, bodily autonomy does not apply to a state-enforced vaccine. As Groucho Marx said: “These are my principles; if you don’t like them, I have others.”

Victims of covid injection injuries receive little sympathy from the compliant majority, partly due to media censorship but also because any reported cases challenge the narrative that the vaccines are safe and effective. Here is a random but revealing exchange on Twitter:

“My brother died suddenly 2 days after the booster, my husband died with covid as a contributing factor and was fully vaxxed. My hairdresser had covid got vaxxed after and is now in renal failure waiting on a kidney. I had it in the beginning pre vax and lived to tell no vax.”

The reply: “Here’s the thing about ‘science’... your anecdotes are statistically insignificant and therefore, not information reliable enough to base future decisions on. Your anecdotes then become what we call ‘dangerous misinformation’. Please stop.”

Joseph Stalin would have liked that reply, having once remarked that “a single death is a tragedy; a million deaths are a statistic”.

The silencing and smearing of people with vaccine injuries, or even of fatalities, is incredibly insensitive. This general hatred was apparent when James Delingpole was invited to Michelle Dewberry’s GB News show to discuss the government’s reluctance to compensate citizens who followed guidance to take the experimental injections.

The debate drew publicity and an exchange between Delingpole and think-tanker Joanna Williams, who responded to a catalogue

of harmful outcomes from the injections with a “you’re being very conspiratorial, James” comment. Williams is a regular contributor to Spiked website, which offended many readers with its shilling for Big Pharma’s lucrative but ineffectual inoculations.

The debate highlighted the ascent of collectivist ideology. As a vaccine proponent, Williams claimed that “for millions of people it’s been safe and it’s actually saved a huge number of lives.” Former editor of Labour List, Peter Edwards, argued that ‘rare’ vaccine harm should be put into context, declaring that “I want to support public confidence in the vaccine, not undermine it.”

Dewberry challenged Edwards on how the majority who were not seriously harmed overrides any concern for those whose health has been significantly impaired. This would be like a car manufacturer shrugging his shoulders at a serious fault in the braking system, because only a few people had died. Why is Pfizer treated preferentially?

On Conservative Woman website *TCW*, Gary Oliver noted: “The hapless victims are hitherto healthy people who had no need for injections, which have proven much less effective but far more dangerous than had been promised. Yet still Peter Edwards and other zealots obstinately hail the unnecessary mass vaccination as having been for the greater good, with the resultant deaths and disablements blithely brushed aside as collateral damage.”

Such denial of individual rights and fundamental freedoms is supported by a puritanical minority, and facilitated by a gullible majority. The growth of communistic attitudes did not begin with covid, having been nurtured in schools and universities for decades, but compliance with lockdowns, masking and vaccination show the great strides made in a short time. Secularism has largely replaced Christian faith and the concept of free will.

Great Fire of London was an inside job

French arsonists scrubbed from event's history

MANY are aware that we are living through a massive rewrite of our history. Far less people seem to be aware that this has happened before.

For, as George Orwell chillingly explained in *Nineteen Eighty-Four*, each rewrite also requires that the population are made to forget that the changes ever happened. So, if our history has been changed before – how would we know?

The obvious starting point is to look at old history books and see if they tell a different story to the one that we are told now. Unsurprisingly they do, and the differences and changes are plain to see - the difficult part is getting people to look. For, as with most things, most of the population have been convinced to fall in love with the new version that they are first told - to the point of taking any criticism of it personally and emotionally, rather than rationally.

Getting people to fall in love with the official narrative, on whatever subject, is a major goal of the successful tyrant, and is in many ways the most disturbing.

Possibly the most glaring example of a rewrite that we have all been conditioned to accept is the account of the 'Great Fire of London'. Isn't it strange that this is one of the first stories taught to almost every schoolchild in Britain? It is even more strange that the version we are taught is nothing like the original account of what actually happened.

Almost everyone with a child will have shared in the fun of building a model half-timbered house and learning about the fire starting at the bakery on Pudding Lane. Strange indeed, as a parliamentary inquiry completely cleared the hapless baker, and when you think about it, a baker's oven is designed to withstand fire better than just about anything, and

There were other suspicious circumstances: the old St Paul's Cathedral was 'under repair', with barrels of flammable tar sitting around, and the main steeple packed like a tinder box ready to blow – which it did. The water supplies that would have been used to fight the fires across the City had been turned off the day before and were unavailable. This was starting to look like an 'inside job'.

Multiple eye-witness reports of arsonists being caught red-handed across the City provided the most damning evidence that the fire had been started deliberately.

It also explained how the fire managed to spread upwind and miraculously leap over some areas, only to land in and destroy others. It even managed to cross the mighty River Thames – against the wind!

The arsonists spoke French and were disguised as monks; even though most were captured, none were ever brought to trial. Bizarrely, their rescuers were members of the Duke of York's own household cavalry and even the Duke - the future James II - himself. The heavily-armed knights demanded that the prisoners be

handed over to their custody, and were never seen again. Presumably they were spirited across the Channel back to France.

In his book *Architecture of Power*, Robert Shaw reveals that the view at the time was that the fire was indeed planned in advance and executed with at least the cooperation of the Royal Household. More disturbingly, it was just one of four Biblical-style apocalypses that were deliberately inflicted on London's citizens by their own rulers.

After the famous scientist, Robert Hooke, had observed the connection between rats and the plague, cats and dogs were banned from the City, causing the rat population to explode - surely no coincidence. Shaw also reveals how the rich avoided becoming infected themselves – nutmeg didn't become so stupendously expensive due to a rice pudding craze!

War was also started against what should have been Dutch allies, and before long the food started running out as London suffered the fourth of the apocalypses. Fire, pestilence, war and finally famine had all arrived around the curiously-numbered year of 1666.

The two traumatised sons of King Charles I, Charles (II) and James (II), were no doubt motivated to take revenge upon the City that had 'closed the gates' on their father, and the Parliamentarians who beheaded him for treason in 1649. They believed that the monarch was God's representative on Earth, and that the people had therefore committed 'deicide', deserving a Biblical-scale retribution.

But what were the motivations of the others involved in this 17th century 9/11?

As well as ushering in the arrival of Maritime Law and the groundwork for the Bank of England, the rulers saw this as the chance to create a new London with vast boulevards, elegant avenues and, bizarrely, a layout based on the ancient Egyptian Osiris cycle – evidence for which can still be seen today.

Sir Christopher Wren produced the plans for the new City amazingly quickly, and all that was needed was for the people to move out for work to commence. The problem was that the people stood firm and would not go. Despite being charged rent on buildings that had been burnt down, the people of London stuck it out and

the ramshackle old streets slowly recovered – first tents, then shacks and then stone.

Wren cried – not for the loss of life - but for the loss of his chance to rebuild London as the rulers wanted it. This is how ruthless they were, and they may have even convinced the Royals to put their death plan in motion.

'The Monument' (to the Great Fire) was erected to commemorate the great death toll, and the French Catholic 'papist' arson plot was inscribed on the stone. This was later erased in 1830, when the political landscape had changed, and the story we're still told today was first fabricated.

Judge an idea by its results, not its intentions

Replacing the 'great reset' with decentralised power will preserve freedoms

IN my previous article (see below), I outlined the main arguments for the 'great reset' that are being pushed by the World Economic Forum (WEF). The intention of the technocracy is to control the problems that our current economic system has created.

Large businesses, governments and investment companies will gain economies of scale and have enough data to allocate the resources in the economy in the most efficient way. The environment will be protected, wastage stopped and harmful activities controlled.

If you listen to the WEF at their conferences in Davos, you might believe that their intentions are good. However, I believe we should judge ideas by their results, not their intentions. Utopian ideas are sold using good intentions, but as is the case with the WEF technocracy, the result will be a loss of freedom and autonomy that will completely change the human experience forever.

Economics is a social science, and there are many ways to solve problems and allocate resources. I will set the scene for the problems

created by the current economic system according to the Austrian school of economics, or a system that promotes a decentralised economy.

The Austrian school was created by Ludwig Von Mises after fleeing Nazi Germany due to his Jewish heritage. As a result, the Austrian school of economics has a very different view of how governments should behave. To view the economy through the Austrian lens, we can assume that consumers aim to maximise their benefits, producers aim to maximise their profits, and governments aim to maximise their power.

Under neoclassical thinking, a business leader or investor who ruthlessly cut corners to maximise their profits would suddenly become benevolent if they became a government official and would use their skills to maximise everyone's well-being.

Under the Austrian school of economics, the same person would be assumed to create a much bigger problem of increasing power for themselves and their big industry buddies. Some evidence for Austrian economists' assumptions can be observed if we look at the impact of lobbying and many government officials' second jobs. It is clear that more powerful governments have allowed influence, particularly in the pharmaceutical industry, energy and banking industries, to increase.

So, according to the Austrian economists, the problems of our current system are created by an unholy alliance between big business and big government. Pollution is caused by regulation that allows loopholes, while multinational businesses can move to countries with fewer environmental laws. Inequality is caused by complex tax laws that require specialists that only the big businesses can afford, and this allows larger businesses to keep the majority of their profits to expand their operations and crush the smaller opposition.

Government-granted patents and contracts reduce competition and innovation so as to concentrate power in fewer hands. As a result, the technocracy of the WEF will create a dystopian nightmare, and not a solution to the problems they

have created.

The Austrian economists have a different view of the solution to the world's problems - decentralisation. If we assume that the government maximises power, the best solution in a decentralised economy is to limit government's influence. This can only be done in a free-market economy if the consumers maximise their benefits by thinking rationally and altruistically.

Under our current system, we are trained to follow the expert's advice, our choices are influenced by business advertisements and we are nudged in our values and opinions by government/corporate programmes. We are taught to prioritise society's values and needs more than our own.

The Austrians turn this on its head and suggest that individuals should aim to find their own individual purpose before joining society. In this way, society is created through the cooperation of the individuals within it, to achieve their separate aims.

Society functions because through this cooperation, each individual is better off. The aim of the individual is to be independent or self-sufficient from society, allowing individuals or groups to

leave society if an economic agent becomes too powerful, or they disagree with the direction society is heading. This self-sufficiency may be created individually, or in small groups of like-minded individuals, limiting anyone's power.

For decentralisation to be a viable alternative to the WEF great reset, it has to be able to solve the two main problems of our current economic system: the destruction of the environment and inequality. It is at this point that I must emphasise that complete decentralisation is an end goal, but it won't be reached in a short space of time.

However, I believe that with the added incentive of avoiding the WEF technocracy, societies can figure out how to remain free whilst solving these problems. In a decentralised system, protection of the environment has been studied by the economist Eleanor Ostrom, who observed tribes and small communities in areas of Nepal. These groups achieve an equilibrium with their surroundings through social contracts.

Ostrom found that using central planning or pricing actually created an incentive to cheat and overuse resources. Adam Smith also devised theories of how to reduce inequality

in a market system, through creating more honour and respect among those that give away their money. This can be in the form of charitable donations or welfare projects. He hypothesised that it was this honour and respect from society that the successful crave. Charitable donations can give this honour and reduce the need for a government-regulated welfare state. Charities must also be open and transparent to incentivise donations.

There are many people who believe in the WEF ideas of technocracy, and the safety that this will bring. The problem with the plan is that a vocal minority will always reject the censorship, manipulation and fear that must be present to control large groups of people's behaviour. A decentralised system will allow this vocal minority to move to their own system of self-sufficiency. People should then be free to choose the system that is right for them.

Countries should look at Swiss model to serve their people

SERIOUS problems require effective solutions and when you have democracy in free-fall, you need a proven fix.

Our 'representative' system no longer comes close to reflecting the will of the people. Instead, it seems to merge with the dodgy deal-makers in the World Economic Forum (WEF), the bean-counters at BlackRock and the unelected pension-scrungers at the EU and UN.

We propose a hybrid, balanced system that has been trialled and perfected over nearly two centuries in an ever-growing number of countries across the world. This hybrid democracy was first adopted in Switzerland in 1848, and has been so effective in terms of the happiness, prosperity and the education attainments of its people, that even the WEF recognises its leadership in these fields.

However, ask yourself why Switzerland was kept out of the

G20 after it rose to be the 19th largest economy in the world. Why might egocentric politicians bar this direct democracy-powered, hyper-successful hybrid country from having a voice?

Were they perhaps worried that people might notice this small country demonstrated that direct and representative democracy can complement one another? That it can work better than any other government system? Even worse for the politicians, the Swiss MP-equivalents only attend four three-week sessions per year. Yet these part-timers manage a nation of eight million better than full-time SNP types do one of five million in Scotland.

Maybe this is why narcissists, who are willing to enrich dodgy medical sales outfits and property-developing tax-dodging schmoozers, put their hands up in horror at the sober Swiss types who really do put the interests of their people first.

The time for action is now, as any delay may be fatal to our freedom.

It may come as a surprise to find out that direct democracy is not only very popular, but much

more commonly used than most believe.

In 2018, Pew Research found that 70% of European adults believed that public referenda (The People's Veto) would be a good way to govern their country. All European countries - bar three - have provisions for referenda, and six have initiatives. In the U.S., 24 states allow initiatives, and California has had 56 recall petitions since 1919, even for judges, as they are elected too.

Both Theodore Roosevelt and Woodrow Wilson advocated the introduction of the initiative, but have you ever heard a British politician do so? Well the Liberal MP, Robert Wallace, proposed that we adopt the referendum and the initiative - in 1896! Still waiting...

The boys from the Eton Rifles believe that they were born to lead, leaving the plebs to suffer what they will. Not so the Geneva Gunners, who share leadership with their fellow troopers in the march to freedom and peace - would it also surprise anyone to recall that the Swiss have not been at war since 1847?

An argument is put by the

Oxbridge types that the lower orders will vote for low taxes and high expenditure, but this is not the actual experience. When people are involved in the decision-making and made aware of the facts, they increase taxes if deemed best, that's the fact. In contrast, how have our MPs done? How is quantitative easing (printing money and supercharging inflation) going? Had your energy bill yet? It's time for the adults to take the toys away.

In essence, the major benefit of the hybrid system is the introduction of a people's veto on all laws as they are issued by our MPs. You will have the right to gather signatures from others who support you in stopping a law coming into effect, and if you get enough in a fixed time period, you earn the right to a first-past-the-post referendum on whether the law is to be adopted.

In addition, the recall process we already have in place can be tightened up, so that it is easier to give crooked, self-serving and incompetent MPs the heave-ho.

Our movement has begun the process of acquiring access to a

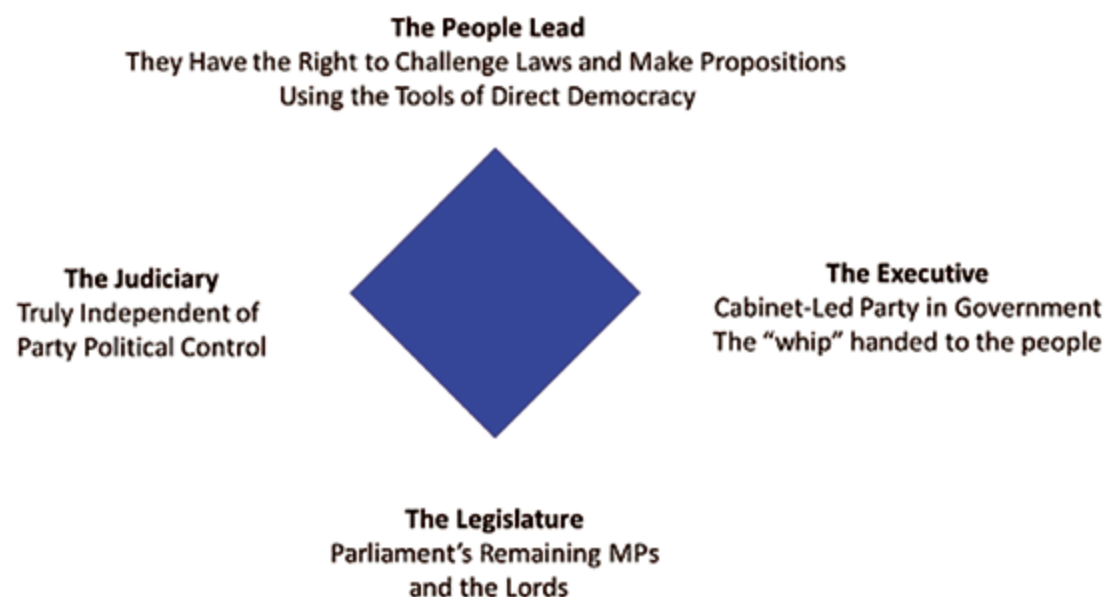
voting platform that will allow you to vote on upcoming bills in Parliament, thus guiding your safe-seat MP, or councillors, as to your wishes.

The U.S. may be the final battleground for freedom

The covid-19 military project will unravel where it started

IN 1961, President Dwight Eisenhower issued this warning: “In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military-industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.”

Reiner Fuellmich, the consumer protection trial lawyer, and his legal colleague Viviane Fischer, who together founded the Corona Investigative Committee, have for the past two years interviewed hundreds of scientists, physicians, economists, researchers and statisticians to gather evidence to hold to account the perpetrators of a mass illusion.

This illusion was projected onto society using psychological terrorism and physical threats, and culminated in the coercive administration of dangerous injections. Reiner believes the unravelling of the web of lies and deception will occur first in the U.S. He is not alone in predicting that the house of cards will collapse at the place of its conception.

Reiner’s reasons are of a practical nature. There has been a constant stream of lawsuits filed against illegal mandates, resulting in some well-written decisions by judges, as he believes that in the U.S., ‘at least part of the judiciary still functions’. One of the most successful legal challenges was the one brought by Public Health and Medical Professionals for Transparency (PHMPT) against the FDA, which forced the release of the Pfizer clinical trial documents they had wanted to hide for 75 years.

Across the country,



organisations and groups of individuals and employees have generated a critical mass of class actions against district, state and government authorities, public health and school authorities, hospitals, airlines, and any authority acting ultra vires (beyond its powers) to impose illegal requirements. The plaintiffs have argued government overreach, discrimination against religious beliefs, violations of the Constitution and, thanks to the whistle-blower, Brook Jackson, Pfizer is having to answer allegations of fraud under the False Claims Act.

This is how momentum builds. The stream becomes a river and then bursts its banks, and civil lawsuits, and even criminal prosecutions, may soon flood the courts. The judiciary itself will then naturally align with public opinion.

For a year, the Biden administration has been pretending that the Pfizer BioNTech covid-19 vaccine being administered to the American people is fully approved by the FDA. But like so much in this illusion, it is sleight of hand. What was approved by the FDA on 23rd August 2021 was a different version of the shot, to be marketed as the ‘Pfizer Comirnaty covid-19 vaccine’, which was not, and is not available to the American

population. But to allegedly overcome the ‘vaccine hesitancy’ of 30% of the population, Biden himself announced that the Pfizer shots were now fully approved, and this deception was used to reinforce certain mandates. All four covid-19 ‘vaccines’ in use in the U.S. remain under Emergency Use Authorisation (EUA) only.

Also underpinning the legal endeavours, Reiner Fuellmich opines, is the 2nd Amendment of the U.S. Constitution - the right to bear arms. Whilst he never warmed to it, in this particular moment it constitutes a balance of power, because he estimates that between 40-50% of the American population will not tolerate more mandates, possibly planned for this Autumn.

In 1776, the colonists felt oppressed by taxes imposed by a remote government in which they had no representation. So they asserted their values, set out in three simple truths that were to become the founding principles of a new independent nation, providing recourse for any future abuse of power or deviation into tyranny:

- That all men are created equal
- That all men have their rights given by God
- Those rights are of life, liberty

and the pursuit of happiness.

And for those who place their trust in the laws of natural justice, there is something intrinsically just in the notion that where the evil began, there shall it be first repelled.

The final two chapters of Robert F. Kennedy Jr.’s *The Real Anthony Fauci* explain the dark mechanisms of America’s post-war domestic and foreign policy. Chapter 11 is entitled *Hyping Phony Epidemics: “Crying Wolf”*, and chapter 12, *Germ Games*.

In 2001, a smallpox outbreak simulation named ‘Dark Winter’ was staged. Issues of public health never entered the equation; the focus was how to impose control over the U.S. and world populations during public health emergencies, and how to sweep away civil rights and impose mass obedience to military and medical technocrats. In essence, how to impose martial law in long-established democracies with built-in checks and balances.

In January of 2003, and again in 2005, a cabal of U.S. and European military, intelligence and medical officials germ-gamed another exercise they called ‘Atlantic Storm’. Characteristically, it designed militarised strategies including how to use police powers to detain and quarantine

citizens; how to control messaging by deploying propaganda, and imposing censorship to silence dissent; how to mandate masks and lockdowns, conduct track-and-trace surveillance of potentially reluctant populations; and how to suspend civil rights and due process rule-making, in favour of diktats by health authorities, all aimed at coercive vaccination of the population.

Important to understand is that the term ‘bio-security’ is a euphemism for biological warfare, and that the Pentagon/Fauci gain-of-function programmes are predatory in nature. Coercive vaccination is a CIA military objective, a foreign policy tool in the U.S. 21st century empire ambition. Between 1947 and 1989, the CIA were involved in more than seventy coups d’état across a third of the world’s countries. Many of these had been functioning democracies.

In 1998, Robert Kadlec created an internal strategy paper for the Pentagon, promoting the development of pandemic pathogens as a stealth weapon to be used against its enemies without leaving fingerprints:

“Biological weapons, under the cover of an endemic or natural disease occurrence, provide an attacker the potential for plausible denial. Biological warfare’s potential to create significant economic losses and consequent political instability, coupled with plausible deniability, exceeds the possibilities of any other human weapon.”

The lull in restrictions on everyday life over the summer should not blind anyone to the fact we are at war. The autumn will likely bring more planned disruption to our lives, whether by financial and economic collapse, renewed manufactured virus outbreaks, or other grand deceptions, leading to more draconian laws and restrictions.

But these are signs of desperation. We can and must weather the storm. The U.S. may lead the way, the UK could be next, and the EU countries might take a bit longer but will follow, moving us closer to freedom.

Norwegian woman faces jail for stating ‘men cannot be lesbians’

Police investigating tweets claiming men cannot be lesbians

A NORWEGIAN self-described feminist is facing up to three years in prison due to a number of no-nonsense, common sense tweets, asserting that men cannot be lesbians.

Between February 2021 and January 2022, Christina Ellingsen, a member of the world feminist organisation Women’s Declaration International (WDI), tweeted, “why (does) FRI teach young people that males can be lesbians? Isn’t that conversion therapy?”

Her not-so-controversial tweets were directed at Christine Marie Jentoft, a representative for a Norwegian trans-female activist group Foreningen FRI. Jentoft was born a biological male but now identifies as a lesbian woman.

Another tweet that has reportedly been deemed as hate speech, read: “Jentoft, who is male and an advisor in FRI, presents himself as a lesbian - that’s how bonkers the organisation which supposedly works to protect young lesbians’ interests is. How does it help young lesbians when males claim to be lesbian, too?”

In response to the investigation, Ellingsen spoke with Reduux, a pro-woman, pro-child, safeguarding online news platform. She said: “I am under police investigation for campaigning for women’s rights, because to certain groups, the fact that women and girls are female and that men cannot be women, girls, mothers or lesbians, is considered hateful.”

“Women are not protected against hate speech in Norway, but men who claim to be lesbian and a woman, are protected both on the grounds of both gender identity



and sexual orientation.

“The fact that police are legally able to investigate and persecute women who engage in women’s rights is concerning. This is new territory in Norway, so the outcome of the investigation is important, either if the case is dismissed or if it leads to a trial.”

Faux do-gooders Amnesty International Norway also got in on the act, by accusing Ellingsen of harassing Jentoft during a TV debate that centred around the topics of biological sex, language, and trans health. During the debate, Ellingsen said to Jentoft: “You are a man. You cannot be a mother. To normalise the idea that men can be mothers is a defined form of discrimination against women.” Ellingsen alleges that Jentoft filed a complaint to the Norwegian police after the TV discussion.

Norway introduced gender identity into the hate crimes law in 2021.

Ellingsen told Reduux: “Women make up the majority of those who donate to charities. Do women realise what they support when they [donate to] Amnesty International? I think that by backing the most exploitative

industries against women, and by supporting the erasure of women as a sex-class, Amnesty might be making a mistake.”

In an interview with Tucker Carlson, Ellingsen said: “You can’t defend women if you can’t define what a woman is.”

One of Ellingsen’s critics is a professor of ethics at Oslo called Ole Martin Moen. In 2015, he published a controversial paper titled *The Ethics of Pedophilia*, which was published in the *Nordic Journal of Applied Ethics*. In the opening abstract of the paper, Moen said: “Pedophilia is bad. But how bad is it? And in what ways, and for what reasons, is it bad?”. He also called for the normalisation of paedophilia to be taught in schools. The professor currently serves on the board of a trans-activist lobby group in Norway.

Once again, George Orwell was prophetic when he said, “the further a society drifts from the truth, the more it will hate those that speak it.” Speaking common sense and stating the obvious will soon be seen as a revolutionary, and criminal, act.



French farmer wins court case over 4G phone tower

40 of 200

livestock died after mast installation

A RESOLUTE farmer in central eastern France recently won a battle in court, resulting in a court order requiring local authorities to temporarily turn off a 4G antenna for two months, over animal welfare concerns on his farm.

According to Mr Frederic Salgues, since the installation of the 4G antennas in July 2021 - 200 metres from his farm - 40 of his 200-strong herd had died, his herd were feeding less, and milk production had decreased by nearly 20 per cent, all within days of the cell phone tower being switched on. He added, “there are no medical elements that could [otherwise] explain this brutal drop in milk production.”

In May 2022, the administrative court in Clermont-Ferrand ruled in favour of the French farmer by stating that, “it is appropriate to order the temporary cessation of the operation of this antenna for a period of two months, taking into account its general impact, with monitoring by the judicial expert of the behaviour of the herd, and

of the dairy cows in particular, during this period.”

The mobile network operators who installed the 4G antenna now have three months to act on the court’s recommendations. A judicial expert has been tasked with monitoring and supervising the entire process, to record data and compile a detailed report in their findings, to see if there is a definite link between the antenna and the odd behaviour of the livestock.

In 2021, in a separate incident regarding 5G technology in France, two Catholic monks based near Lyon were arrested for setting fire to a 5G antenna. According to Agence France-Presse (AFP), the men admitted to the crime, telling a local prosecutor that they acted to “protect the population from the harmful effects of 5G.”

After the positive court ruling, Mr Salgues told AFP News, that he hoped his cows would be able to “recover as soon as possible” and called the case ruling, “a major relief, redemption and a victory.”

In Europe and beyond, farmers are leading the charge against authoritarianism, and are proving a force to be reckoned with.



‘Stalin’s nanny’ appointed to the World Health Organisation

Michie takes on top role covering behavioural insights

BRITISH scientist and longstanding Communist party member, Susan Michie, has been appointed Chair of the World Health Organisation’s Technical Advisory Group on Behavioural Insights and Sciences for Health.

Professor Michie was a member of a sub-group advising SAGE, the UK government’s health advisory body that imposed draconian lockdowns and mandates.

The health psychology professor was a keen advocate and zealot in trying to bring about stringent ‘zero covid’ communist-style restrictions in the UK, including a Christmas lockdown. Michie was a regular contributor on mainstream TV and radio, with constant doom-laden forecasts. She once likened opening up society again to building “terrifying new variant factories.”

In an interview on Channel 5 in 2021, when pressed about the timeline of masks and social distancing, she said: “I think forever, to some extent.” During the same interview, she compared and normalised covid restrictions to wearing a seatbelt and picking up dog poo in a park.

Michie was a key player in weaponising fear by using covert psychological tactics on the population to push the covid narrative in the UK. It comes as no shock that the WHO would appoint the likes of Susan Michie to their ranks. Recently re-elected to serve a five-year term, Director-General of the WHO, Tedros Adhanom, also has a questionable communist past.

Originally from Ethiopia, he



grew up in the northern Tigray region and became a member of the communist-leaning Tigray People’s Liberation Front (TPLF). He rose through the ranks of the TDLF party, leading to important roles in the Ethiopian government - first as Health Minister and then as Foreign Minister.

A former Nobel Peace Prize nominee, David Steinman, has accused Tedros of genocide for his alleged role in directing security forces to kill and torture its own people from 2013-2015. Steinman has lodged a complaint at the International Criminal Court in the Hague. Tedros has denied the allegations.

Steinman claimed that while Tedros was in a senior government position, the regime was “marked by widespread or systematic crimes against humanity by subordinates”. Steinman was a foreign advisor to the Ethiopian democracy movement for 27 years.

Tedros is a close ally of the communist regime in China, and heaped undeserved praise on their initial covid response back in January-February 2020. He hailed the Chinese response to covid as “beyond words”. It is no coincidence that China has made financial contributions to both the Ethiopian aid budget, and to the WHO, while Tedros has been in charge.

It should therefore come as little surprise that the WHO have selected a self-confessed communist to their ‘Nudge Unit’. Susan Michie will fit right in with her new comrades.



Spanish courts pave way for future digital ID

Court rejects action to stop state coercion

What a difference four years can make. In the autumn of 2017, the Catalan regional government, the Generalitat, stood defiantly against its Spanish counterpart in its quest for self-determination.

Fast-forward to the winter of 2021, and its latest act of defiance was to introduce the vaccine passport, brazenly contravening the Spanish Constitution on the grounds of discrimination, curtailment of freedom, and deprivation of intimacy through the enforced divulgence of private medical data as a condition of entry to public establishments. Six months later, the Spanish High Court of Justice has effectively sided with them.

Catalonia was one of eleven out of the seventeen autonomous regions in Spain which voted to implement the illegal measure. When the digital covid passport was introduced on November 26, 2021, its inception had to be delayed for a week due to the overload of downloads.

Even those who disagreed with it felt they could not afford to be without it, prizing social inclusion and Christmas-as-usual above the sinister implications of state coercion. Fearing reprisals and financial penalties, the majority of establishments complied and immediately began barring their unjabbed clientele. Meanwhile, the jabbed packed into bars and restaurants like sardines.

The response among the awakened was swift: a weekly protest march several thousand strong severed the centre of Barcelona every Saturday night, along with similar demonstrations in most other major cities. Of course, the media ignored these, with only one short TV news item referring to ‘a couple of thousand negacionistas (deniers)’. But they were gaining support, people were cheering from their balconies and these supporters began to outnumber those abusing the protesters as they passed by.

We became organised, and within a few weeks, several

lawsuits had been filed. A Telegram group, started by a handful of people in our village, had more than a thousand members two days later. Forty of us came forward to file our own lawsuit against the Generalitat, citing the numerous national and international acts and treaties it was violating.

In fact we filed five - our lawyers felt that dividing ourselves into a five-pronged attack would be a stronger tactic. Given the rocky political relationship between the Spanish state and the Generalitat, particularly in the light of the 2017 push for independence, we hoped that the Spanish justice system may again seek to punish the Generalitat by revoking its vax passport.

We then formed an association, the Association for Resources for Freedom, to crowdfund legal costs and also offer resources and training to members in areas such as common law, children’s rights and social media censorship.

The lawsuit passed through its various judicial stages, the first of which consisted of our request for the immediate revocation of the passport, given its unconstitutional nature. This was not well received either by the Generalitat or the High Court, who responded by imposing costs of €2,000 on all five of our groups. This was a highly irregular and unusual move, given that no costs had been incurred by any party at this preliminary stage, but it sent out a clear message that they were going to play dirty. Crowdfunding €10,000 so early in the process would be a tall order, so on the advice of our lawyers, we proceeded with only one of the five lawsuits.

By this time, the vaccine passport had been revoked, having lasted a day over two months, the Generalitat being forced to admit it had not been effective. This slightly shifted the focus of our action. We were now campaigning to try and ensure that any punishment the Generalitat received would deter them from ever reintroducing the measure.

Unfortunately, our story has no happy ending – the High Court ruled in favour of the Generalitat, that the measure had been taken in good faith, effectively applauding them for taking appropriate action.

The Constitutional Court,

which in 2017 had condemned the declaration of Catalan independence as unconstitutional, resulting in the exile of the President and the ruthless imprisonment of nine Catalan politicians, made no criticism of the unconstitutional act of enforcing an experimental medical procedure.

They simply gave the Spanish government a slap on the wrist for breaking legislative protocol in allowing the regional governments to approve such measures. In our case, as a nod to the plaintiffs, no further costs were imposed by the High Court in recognition of our right to challenge a legislative impropriety, but this was worded in such a way so as to imply that it was a deterrent not to pursue the matter further through the Supreme or European courts.

The 2022 reform of the Spanish National Security Law, granting the government powers to seize any goods or property in an arbitrarily-declared ‘state of emergency’, clearly illustrates that the central government is no friend of the people. Imagine how difficult it would be for them to enforce their own future vaccine passport had they condemned one of their regional governments for doing so.

The members of our group involved in the remaining lawsuit were advised by our lawyers that to continue would be to risk severe financial penalties, with the Supreme Court highly unlikely to overturn the ruling of the High Court or waive costs a second time. However, the costs we incurred for calling for an abolition of the passport are currently subject to an ongoing appeal.

The tide of public interest had also turned, with most people’s sense of outrage having waned since the passport disappeared. The outcome of the case is simply another example of how political and ideological differences can easily be put aside among the ruling institutions when the people are the enemy. The people should act likewise.

New initiative to combat hysteria of war

People don't want war but politicians do

WHAT is it that turns man into beast when a war breaks out?

In 1914, only five British MPs voted against declaring war on Germany, yet there were widespread suspicions of a secret deal between Britain and France, in which Britain would send troops to France if it were attacked by Germany.

One of those MPs was Arthur Ponsonby, who later wrote a book called *Falsehood in War-Time*. He revealed not only the lies told during the war, but the lies told in order to get Britain into war in the first place. Had that been known for certain at the time, there would probably have been no war.

In 2012, an influential U.S. think tank, The Washington Institute for Near-East Policy, held a seminar under the title How to Build U.S.-Israeli Coordination on Preventing an Iranian Nuclear Breakout. In reality, it was about how to get the U.S. into a war with Iran.

The institute's research director, Patrick Clawson, stated: "I frankly think that crisis initiation is really tough, and it's very difficult for me to see how the United States President can get us to war with Iran".

He went on to summarise the traditional ways of getting to war, and concluded by saying: "We are in the game of using covert means against the Iranians" - and that they could get nasty with it.

It would appear that all wars are started by a Big Lie, which leads whole populations to believe that they are under an imminent threat from the other side. The invasion of Iraq was no exception, although Tony Blair was one of the few British Prime Ministers to get caught red-handed.

Even if there is no war, it seems some people are in a war mentality. They seem to believe they are acting out of patriotism, when that

sense of loyalty is not to the people of the country, but to the political and banking elite, who largely control the minds of the people.

Whole populations can believe different things, because they are trusting of those who hold authority in their respective countries. This is linked very much to language, which is not only a means of communication, but also a badge of identity.

The fighting in Ukraine is not explicitly about language, but language differences play an important role in the definition of 'two peoples'. When the language of one is suppressed by another, then one of the two peoples is being suppressed by the other. In Yugoslavia, Serbian and Croatian were previously thought of as two dialects of Serbo-Croat, until fighting broke out, when each of those two peoples had to be careful which words they used when mixing with the other.

Even in Northern Ireland, where they all spoke the same language, they didn't all identify with the same language. "Do you realise I don't speak my own language?" one Irishman once said to me.

Populations are kept separate, so as to minimise communication across boundaries. The authorities don't want their Big Lies to be revealed by anyone. As former politician and social activist, Arthur Ponsonby once said, lying is an integral part of warfare. The purpose may be to mislead the enemy, or it may be to harness the support of their own population.

But without a Big Lie preceding the outbreak of hostilities, there would be no war in the first place.

So to get even limited contact between people on both sides of a war can be quite challenging. Russia and the UK are effectively in a proxy war in Ukraine.

The August meeting of Keep Talking in London was possibly a first in bringing together people from both sides, with a video link to three Russians in Moscow and St Petersburg, with a live audience

in London. The three Russians had appeared in a 'List of Shame' produced in Poland, vilifying them as warmongers.

I later managed to get into some correspondence with the person who had drawn up that list, who told me that the names were given by 'others', and he couldn't himself give me the evidence. When I managed to contact one of the 'others', I was met with evasion and abuse.

All three Russians had been active in the Universal Esperanto Association, and the whole point of this movement was to enable ordinary folk on both sides of disputes to be able to communicate with each other, outside the arena of language politics.

The founder of the movement, Dr L. L. Zamenhof, was dedicated to trying to understand the causes of war, and doing what he could to at least reduce the ferocity of the constant wars raging in Europe at that time. He died in 1917, mystified at the cause of the First World War.

In order to solve any conflict, one has to first listen to both sides. In practice, the present-day Esperanto association is being

nudged in the direction of typical peacenik groups in crying out 'I'm against the war', without really understanding what that means.

The point of view of the Russians was that the war in Ukraine started in 2013, and was instigated by U.S. sources in Maidan Square. That coup in Kiev was never accepted by the largely Russian-speaking population of Donbass, and so a civil war broke out. That was, in theory, resolved by the Minsk agreement, which allowed the largely Russian-speaking areas autonomy within Ukraine, and the right to use their own language. The Minsk agreement collapsed when Kiev put restrictions on the use of the Russian language, and bombed civilian populations in Donbass.

A video of the whole Keep Talking session, with constant interpretation between the two languages, can now be viewed online (see reference 6), and it gives insights into how war hysteria is whipped up by some of the authorities, and how this can be combated by encouraging people to listen to both sides before being judgemental.

Contagion and infection - appearances can be deceptive

Take back responsibility for your health

THE most common question people ask when confronted with the statement that ‘germs’ are not the cause of disease is: if it isn’t a germ, then what is it?

This question is clearly based on the idea that there is a single identifiable causal agent for each disease, but this is not the case.

People also often ask about the contagiousness of diseases. This is based on a common experience in which a number of people in close proximity, such as family members, display the same symptoms at more or less the same time. This experience is believed to indicate that these people have all ‘caught’ the same disease. In other words, people believe that diseases are both infectious and contagious; but this too is not the case.

The origin of the word ‘contagion’ is the Latin *contagio*, which only refers to direct contact. But according to the Merriam-Webster dictionary, it is now regarded as involving indirect as well as direct contact. This definition allows the medical establishment to claim that so-called ‘infectious agents’ can spread both directly and indirectly, despite the fact that no mode of transmission has ever been proven.

The phenomenon of contagion is believed to be real, because of the common experience of simultaneous symptoms. But, as the adage states, appearances can be deceptive; an adage that holds true for the appearance of an infectious disease.

It is clear that this contradicts the ideas about infectious diseases promulgated by the medical establishment and the media. However, the medical establishment operates from the basis of a flawed understanding of the human body.

The symptoms associated with what are called infectious diseases represent the body’s efforts to expel toxins, repair damage and

restore health. This is explained by Herbert Shelton in his book, *Natural Hygiene: Man’s Pristine Way of Life*, in which he discusses ‘acute disease’, a term that he refers to as, “vital action in some, one or all of the living tissues or organs in resisting and expelling injurious substances and influences and in repairing damages.”

The significance of this statement is that it demonstrates the true nature of disease and the purpose of the symptoms produced by the body.

It is therefore important to recognise that the symptoms each person experiences will be unique to them because of their unique exposures to the ‘injurious substances and influences’ that affect their bodies. However, within the same environment, many people may experience common exposures to them, explaining why they may experience similar symptoms when their bodies initiate the expulsion of those substances and influences.

Furthermore, contrary to the medical establishment view, the human body is an amazing, interconnected, self-regulating organism that functions holistically. Therefore, any substance or influence that injures one part can adversely affect the whole organism, as Herbert Shelton writes:

“The human organism is an indivisible whole, and anything that tends to interfere with the unity of its structure or the unity of its function becomes a factor in the causation of disease.”

Problems can only be solved by addressing and removing their root causes. But the methods employed by the medical establishment that involve the use of pharmaceutical products do not address and remove the root causes of disease, because they do not understand disease or the human body.

It is important to always bear in mind that each person is a unique individual who will experience exposures to a unique combination of injurious substances and influences that can cause their bodies to initiate the appropriate

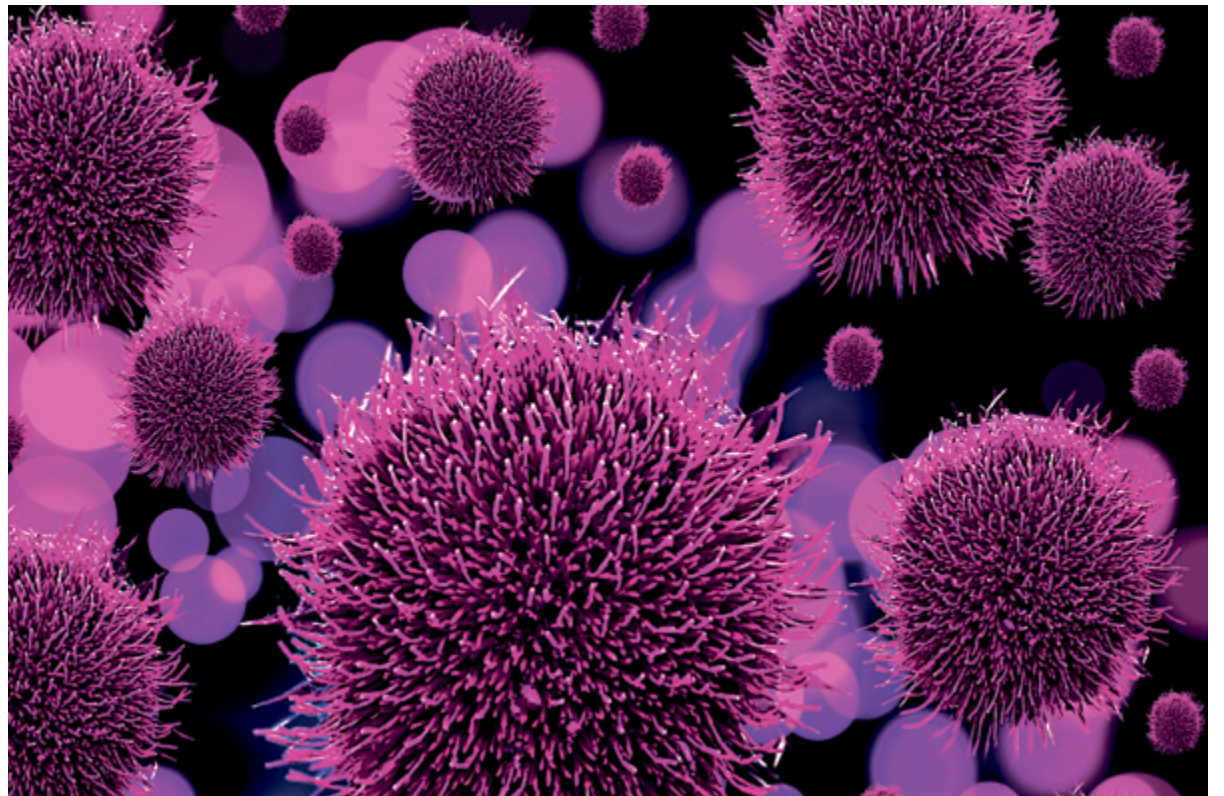

symptoms. The ability of each person’s body to initiate the symptoms required to expel toxins, repair damage and restore health will also depend on their unique health status.

There are clearly many injurious substances and influences to which people can be exposed. We refer to them in our book as the ‘four factors’, which are: inadequate nutrition, toxins, electro-magnetic frequencies and prolonged emotional stress.

The category of toxins includes a huge number and variety of toxic chemical compounds. We are often exposed to them on a daily basis, although mostly at low levels that do not necessarily produce symptoms. But many of these chemicals are bio-accumulative and slowly build up within the body to a level that requires expulsion. At this point, the body will initiate the appropriate symptoms to expel them.

Therefore, when groups of people experience similar symptoms at a similar time, which gives the appearance of contagion, it may be due to common exposure to ‘injurious substances or influences’. However, people may not all experience symptoms with the same severity and duration because this will depend on their

unique health status that will, in turn, depend on any other factors that may affect their health, whether beneficially or adversely.

There are other aspects to the category of ‘stress’ that need to be contemplated, because the term also refers to our belief systems, which include our thoughts, ideas and fears. This may even include a belief that diseases are contagious.

The placebo and nocebo effects are known phenomena that demonstrate the power of the mind; a topic that has been discussed by Dr Bruce Lipton PhD throughout his work for many decades. In his article entitled *Epigenetics*, he explains that we are all indoctrinated into the belief that we do not have control over our health. This means that we are made to feel that we are victims of germs that can infect us and cause diseases that can be spread to other people.

A belief in the transmissibility of disease gives rise to the anticipation of an adverse outcome when a person with whom we may come into contact displays symptoms of what is believed to be an infectious disease, such as sneezing or coughing, for example. The manifestation of symptoms will be taken as positive proof of the transmission of the germ

and strengthen the belief in the phenomenon of contagion.

But a belief in infection and contagion is not the only factor at play when people experience symptoms at a similar time. It is, however, an extremely important factor that has great relevance to our current situation, which is based on the idea that a deadly virus is circulating across the world causing untold harm and death, and can be transmitted between people.

This is an erroneous idea. There is no evidence to support it, nor is there any evidence that anyone can spread any condition of ill-health to another person. Each person’s health status is unique to them and to their beliefs and ideas, including their fears about diseases being contagious. This applies to all so-called infectious diseases and not just covid. There is no reason to continue to believe in such ideas.

This is key to bringing our current situation to an end, because people no longer need to be afraid of catching any disease or passing it on to someone else. But we do need to learn how to take back control over, and responsibility for, our own health.

No evidence that depression is caused by a chemical imbalance

RESEARCHERS from University College London (UCL) have published eye-opening findings that may create a seismic shift in how we view and treat depression.

cannot be boiled down to a simple chemical equation. We believe the situation has been driven partly by the false belief that depression is due to a chemical imbalance.”

The ground-breaking umbrella peer-review meticulously examined all relevant studies and research published on depression and serotonin. The detailed review can be found in the scientific journal *Molecular Psychiatry*, under the title: ‘The serotonin theory of depression: a systematic umbrella review of evidence’.

The professor and consultant psychiatrist, Moncrieff, also questioned the efficacy of antidepressants by stating: “Our view is that patients should not be told that depression is caused by low serotonin or by a chemical imbalance, and they should not be led to believe that antidepressants work by targeting these unproven abnormalities. We do not understand what antidepressants are doing to the brain exactly, and giving people this sort of misinformation prevents them from making an informed decision about whether to take antidepressants or not.”

Irving Kirsch, an American psychologist, researcher and academic, discussed the efficacy of antidepressants in his 2009 book called: *The Emperor’s New Drugs - Exploding the Antidepressant Myth*. He argued that the chemical imbalance theory of depression is wrong, and that antidepressants have minimal therapeutic effect on depression, but because of their common or serious side-effects, antidepressants can be powerful active placebos.

Antidepressant drugs rank third in pharmaceutical sales worldwide. According to a report from *Fortune Business Insights*, the market is projected to reach U.S. \$18.29 billion by 2027.

It is high time that enlightened health professionals and service users questioned the psychiatric and Big Pharma industry over its inaccuracies, pseudoscience, and reliance on popping pills.

‘Still III’, a 1984 song by the band The Smiths, asked the curious question that we should all be asking: “Does the body rule the mind, or does the mind rule the body?”

Joanna Moncrieff, lead author of the study, and professor of psychiatry at University College London, said: “It is always difficult to prove a negative, but I think we can safely say that after a vast amount of research conducted over several decades, there is no convincing evidence that depression is caused by serotonin abnormalities, particularly by lower levels or reduced activity of serotonin.

“The popularity of the ‘chemical imbalance’ theory of depression has coincided with a huge increase in the use of antidepressants.

“Thousands of people suffer from side-effects of antidepressants, including the severe withdrawal effects that can occur when people try to stop them, yet prescription rates continue to rise.”

Co-author of the research, Dr Mark Horowitz, reacted to their findings by saying: “I had been taught that depression was caused by low serotonin in my psychiatry training, and had even taught this to students in my own lectures. Being involved in this research was eye-opening and feels like everything I thought I knew has been flipped upside down. It is high time to inform the public that this belief is not grounded in science.”

The UCL team also highlighted that many studies found that precipitating external factors, such as stressful life events, can increase the likelihood of depressive features. More pluralistic treatment options, such as psychotherapy, alongside practices such as exercise, self-care, and mindfulness, or addressing underlying perpetuating factors such as poverty, stress and loneliness, can greatly help with low mood, said the researchers.

Dr Horowitz said: “One interesting aspect in the studies we examined was how strong an effect life events played in depression, suggesting low mood is a response to people’s lives, and

DEAR Editor,

I'm very concerned that England is going to add fluoride to its tap water. The chemical used is fluorosilicic acid - toxic waste from phosphate fertiliser - factory chimney scrubbers! It's more poisonous than lead and only slightly less so than arsenic. It's not pharmaceutical grade, unlike that in toothpaste. Fluoridation is wasteful and expensive, as less than 1% of tap water is drunk. Most water is used by industry and for washing, watering gardens, laundry etc. 99 per cent of money spent on fluoridation is literally money down the drain!

Fluoride can cause dental fluorosis - permanent mottling of children's teeth. The WHO said that no new fluoridation schemes should be begun until

total fluoride intake has been measured, but this wasn't done. We receive fluoride from industrial pollution, pesticides, antidepressants and other medical drugs.

Many people's fluoride body levels are above WHO safety limits. In Lanarkshire, Scotland, tooth decay is greatly reduced by the "ChildSmile" scheme, where young children clean their teeth properly each day in school.

Medication should be prescribed individually, not given en-masse with no control over dosage received. It's unethical to fluoridate everyone regardless of need, health or choice. You cannot opt out when it's in tap water, so there is no informed consent.

It would be preferable to give free toothpaste to any child deemed to need it, than to wastefully fluoridate the whole water supply. We need to fight this before it's too late.

I find it very worrying that an NHS employee believes the service to be free. There are 46 million taxpayers in the UK, many of whom have recently sustained an increase in their national insurance contributions, partly to fund this wasteful institution. A Cochrane Institute study of influenza vaccines over a ten year period found they had no impact in reducing hospitalisations or deaths, and had an efficacy of 9 per cent, which is equivalent to zero in real terms.

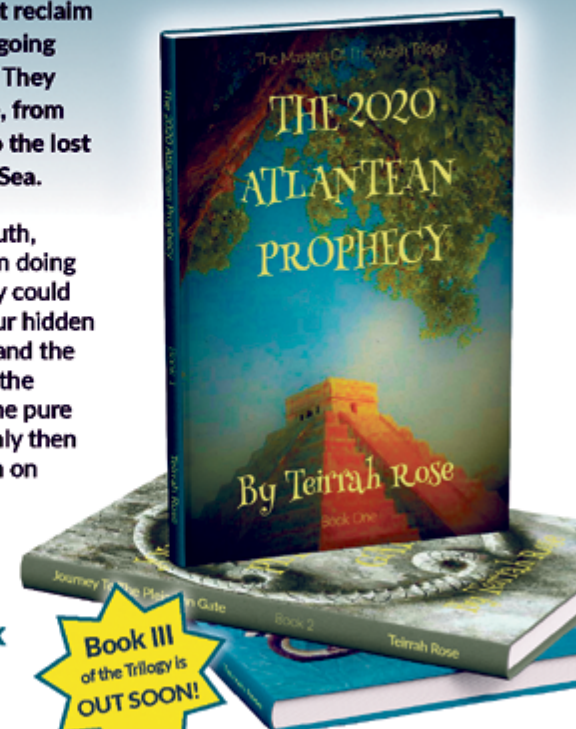

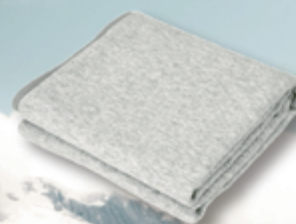
